Included in this document are Terms of Use for:

Personal Use (PU) / Scrap For hire (S4H)

Commercial Use (CU)

Please refer to product preview packaging for the license that applies to each product.

### **PERSONAL USE Terms and conditions:**

- You may use this product for your own Personal use
- You may use this product to create projects or layouts on behalf of a client (S4H) Note: Each S4H client must purchase every product used. (You cannot create a layout template and simply insert a different client's photos in it, unless that client has purchased all of the products included in that layout.) Pages created for your client must be delivered as a flattened jpg or in printed format. You cannot create a layout template and simply insert a different client's photos into it, unless that client has purchased all of the products included in that layout.
- You may not use this product for any commercial use.
- You may not claim as your own, even if altered, resized, recolored, or as part of a layout, page, or cluster.
- These terms are the same for freebies as well as purchased products.
- This product cannot be sublicensed, resold, shared, transferred, or otherwise redistributed on its own (even for free).
- You may create designs for YOUR own blog, Facebook Cover, etc, provided you provide credit on the Facebook Cover graphic to SnickerdoodleDesigns (i.e. Graphics courtesy of SnickerdoodleDesigns). Linkable credit is desired, if possible.
- You may post completed projects online through e-groups, board, galleries, forums, newsgroups, or submit to magazines for possible publication. Credit to SnickerdoodleDesigns is required and appreciated.
- You may alter graphics with respect to color, size, or by adding to or removing from them; however, if you have made changes to my designs, and are posting your graphics in any of the groups listed above, you must state the alterations that you have made.
